2.	To declare a final dividend of US0.37 cents per ordinary share of the Company for the year ended 31 December 2020.		
3.	(i) To re-elect Mr. Edmond Ming Siang JAUW as an independent non-executive Director; and		
	(ii) To re-elect Mr. Shou Kang CHEN as an independent non-executive Director.		
4.	To authorize the Board of Directors of the Company (the “ Board ”) to fix the remuneration of the Directors.		
5.	To appoint PricewaterhouseCoopers as auditor of the Company and authorize the Board to fix its remuneration.		
6.	(a) To grant a general mandate to the Directors to allot, issue and deal with new shares of the Company not exceeding 20% of its issued share capital as at the date of passing this resolution.		
	(b) To grant a general mandate to the Directors to repurchase shares of the Company not exceeding 10% of its issued share capital as at the date of passing this resolution.		
	(c) Subject to the passing of ordinary resolutions no. 6(a) and 6(b), to extend the general mandate granted to the Directors to allot, issue and deal with additional shares in the share capital of the Company by an amount not exceeding the amount of the shares repurchased by the Company.

If you wish to vote against a resolution, please tick in the box marked "Against".** If no direction is given, your proxy may vote or abstain as he/she thinks fit. Your proxy will also be entitled to vote at his/her discretion on any resolution properly put to the Meeting other than those referred to in the Notice.
6. The instrument appointing a proxy shall be in writing under the hand of the appointor or of his attorney duly authorised in writing or, if the appointor is a corporation, either under its seal or under the hand of an officer, attorney or other person duly authorised to sign the same.
7. Any shareholder of the Company entitled to attend and vote at the Meeting is entitled to appoint more than one proxy to attend, and on a poll, vote instead of him. A proxy need not be a shareholder of the Company. If more than one proxy is appointed, the number of Share(s) in respect of which each such proxy so appointed must be specified in the relevant form of proxy.
8. In the case of joint holders of any Share(s), any one of such persons may vote at the Meeting, either personally or by proxy, in respect of such Share(s) as if he/she were solely entitled thereto. However, if more than one of such joint holders be present at the Meeting personally or by proxy, the vote of the senior who tenders a vote, whether in person or by proxy, will be accepted to the exclusion of the vote(s) of the other joint holder(s) and for this purpose seniority shall be determined as that one of the said persons so present whose name stands first on the register of members of the Company in respect of such Share(s) shall alone be entitled to vote in respect thereof.

In order to be valid, this form of proxy must be completed, signed and returned to the Hong Kong share registrar of the Company, Tricor Investor Services Limited at Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong together with the power of attorney or other authority (if any) under which it is signed (or a notarially certified copy thereof) not less than 48 hours before the time appointed for the holding of the Annual General Meeting (i.e. at or before 3:00 p.m. on Wednesday, 23 June 2021), or any adjournment thereof.
10. Instead of lodging this form of proxy to Tricor Investor Services Limited, you may also submit the form of proxy electronically at <https://spot-meeting.tricor.hk/#/690> in accordance with the instructions printed on the notification letter sent to you by post on 24 May 2021.
11. Completion and return of this form of proxy will not preclude you from attending and voting in person at the Meeting (or any adjourned meeting thereof) if you so wish. If you attend and vote at the Meeting, this form of proxy will be deemed to be revoked.
12. Shareholders or their proxies attending the Meeting shall produce their identity documents.
13. References to time and dates in this form of proxy are to Hong Kong time and dates.
14. The Chinese translation of this form of proxy is for reference only and in case of any inconsistency, the English version shall prevail.
